Provide identification (examples in our "Verifying your Identity" list) How to close the account 30 calendar days' notice required to not receive penalty (except in the event of death being registered with the Society for any party to the account). Alternatively you can close straight away but would receive a penalty on the closure amount. Managing your account This account can be managed in branch or by post. Can I withdraw money?	Yes, one notice and penalty free withdrawal per month of up to £5,000 is permitted, all other withdrawals are subject to 30 days' notice. Alternatively, you can choose to withdraw funds without notice and pay a 30 day interest penalty. Please see the reverse of the Summary Box for more information on penalties. Notice: Only one notice period at a time. After 30 days you have 7 further calendar days in which to take out the money.
