Can I withdraw money?	Yes, notice and penalty free withdrawals are permitted. You can normally make a withdrawal on demand of cash up to £500 and any amount by cheque or Faster Payment, subject to adequate cleared balance and written instruction signed by the relevant signatory(ies). All Faster Payments must be made to the nominated bank account linked to the account. Refer to our General Savings Terms and Conditions and the Framework Contract for Payment Services for more information on withdrawals.
